Patient lists accompany all MedicineInsight practice reports. Patient lists contain relevant information about patients including a unique anonymised ID number which will allow re-identification. Patient lists will need to be re-identified at the practice.

The purpose of each list is to assist practices to follow up individual patients should they chose to review in order to reflect upon their patient care and recall patients who may be undertreated, in need of review or potentially at risk based on the MedicineInsight reports.

This guide will assist NPS MedicineWise Educational Visitors and practice staff to re-identify patient lists at the practice.

Re-identify a Patient List

- Save the Patient list file in the format CSV (comma delimited) in an easily accessible place (eg the PC's desktop).
 <u>Please note:</u> Microsoft Excel will show it as a "CSV UTF-8 (Comma delimited) (*.csv)" file.
- 2. Right-click on the Precedence Connector (blue bird icon from the system tray bottom of screen) and select 'Extensions'.



3. Select NPS Re-identification of Patient.
